This information is provided pursuant to:

## PURPOSES OF THE PROCESSING

The Company will process the data you have communicated for the evaluation of your candidacy for the purpose of a possible establishment of an employment relationship with the Company (GDPR, article 6, paragraph 1, letter b).

We also inform you that, as part of the selection process, your data may be brought to the attention of other companies operating within the TANKOA shipyards (partner company). This treatment is necessary for the pursuit of TANKOA's legitimate interest, for the assessment of which TANKOA's organizational needs have been taken into consideration, respect for TANKOA's internal processes, its interest in submitting the application for employment purposes as well as the your right to the protection of personal data (GDPR, article 6, paragraph 1, letter f).

## ORIGIN OF YOUR DATA

The personal data being processed includes the information entered in your CV as well as those that will emerge during the selection phase. We ask you not to insert in the CV particular categories of data (personal information relating to racial or ethnic origin, political opinions, religious or philosophical beliefs, union membership, health, sexual life or sexual orientation, genetic or biometric data) unless the communication of these categories of data, justified by specific and legitimate purposes, is explicitly required by the selection requirements, is justified and necessary for the possible establishment of the employment relationship (e.g. protected categories), is provided for by a legal obligation or concerns personal data that you have made publicly public; in all other cases, any CV containing such information will be immediately destroyed.

### COMPULSORY DATA

The failure, partial or incorrect provision of the requested data, necessary for the pursuit of the purposes illustrated in the specific section of this information, makes it impossible to carry out the selection process.

## RECIPIENT OF THE PERSONAL DATA AND PLACE OF DATA PROCESSING

#### STORAGE PERIOD OF YOUR DATA
