

## VIDEO SURVEILLANCE POLICY UNDER THE PRIVACY REGULATION (version July 2020 – in compliance with EDPB Guidelines 3/2019 V2.0 dated 29/01/2020)

Dear visitors and workers,  
since the headquarters of the companies are in an isolated area with no traffic outside working hours, the spaces of the company TANKOA YACHTS S.p.A. are under video surveillance. The shots area is limited to areas under the authority of TANKOA YACHTS S.p.A. including hard standing and access points but it is not excluded that people passing by in the proximity are subject to shots.  
The present plant, duly authorized by the Territorial Labor Inspectorate of Genoa after consultation with the workers of the plant, does not allow for biometric recognition.  
The Owner invites you to carefully read this policy.

### ORIGIN OF THE DATA AND CATEGORY OF THE TREATED DATA

The images being processed are those collected by surveillance cameras. Each camera is identifiable, and the intended monitoring sign is visible in its immediate vicinity.

### PURPOSES OF THE PROCESSING

TANKOA YACHTS S.p.a. processes the images of video surveillance for the purposes of corporate protection **for the pursuit of its legitimate interest** (GDPR, art.6, paragraph 1, letter f).

In the event of events occurring nearby, the owner may have to act by law on the basis of explicit requests from the judicial authorities.

### PLACE OF DATA PROCESSING AND PROCESSING METHODS

Your data are processed in the territory of the European Union and the processing is normally carried out by electronic means, and occasionally on paper.

### COMMUNICATION OF YOUR DATA TO THIRD PARTIES

TANKOA YACHTS S.p.a. does not communicate the collected data to third parties. It is however possible that, on the occasion of maintenance, they are made visible to personnel of external companies that operate in a confidential relationship with TANKOA. When they operate, these subjects are identified as subjects authorized by the maintenance manager (Data Processor). The personal data collected are not communicated to other subjects (excluding, in case of anomalous events, the Judicial Authority).

The images can only be consulted by subjects explicitly authorized to process them.

### STORAGE PERIOD OF THE DATA

The images collected are kept for about 24 hours except for the holiday periods in which the storage could take place for a longer period (always less than 168 hours).

### YOUR RIGHTS

With reference to your data and its processing by TANKOA YACHTS S.p.a. each interested party can request the owner to respect their rights of access and cancellation of personal data provided that requests are made within the maximum time allowed for the treatment of the images.

You also have the right to make a complaint with the supervisory authority in accordance with the provisions of art. 77 GDPR.
